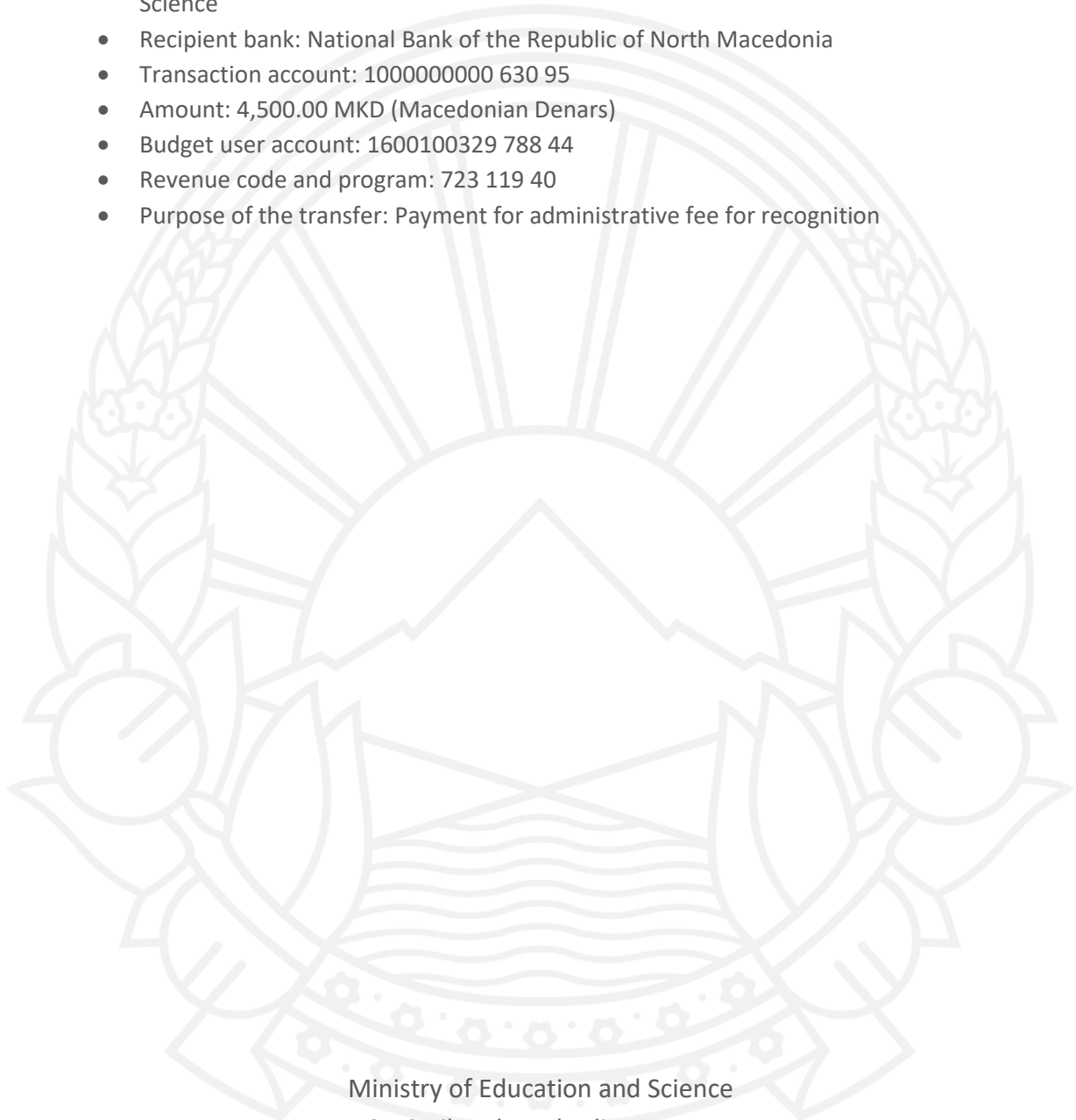

2. **COPY OF THE FOREIGN MASTERS DIPLOMA** (one notarized copy).
3. **TRANSLATION OF THE FOREIGN MASTERS DIPLOMA** (one copy in Macedonian language and its Cyrillic script, notarized).
4. **ORIGINAL CERTIFICATE OF GRADES/TRANSCRIPT OR DIPLOMA SUPPLEMENT** (for inspection).
5. **COPY OF THE CERTIFICATE OF GRADES/TRANSCRIPT OR DIPLOMA SUPPLEMENT** (one notarized copy).
6. **TRANSLATION OF THE CERTIFICATE OF GRADES/TRANSCRIPT OR DIPLOMA SUPPLEMENT** (one copy in Macedonian language and its Cyrillic script, notarized).
7. **STUDY PLAN AND PROGRAM DURING THE STUDY PERIOD.**
8. **MASTER'S THESIS** (in electronic form).
9. **APPLICATION** (form from the Ministry of Education and Science).
